УСТАНОВКА ПАРОЛЯ

Когда доступ к продукту выполняется первый раз, необходимо зарегистрировать пароль входа в систему.

Administrator password change

New password

Confirm new password

- If the password is 8 to 9 characters long, it must include at least 3 of the following character types: English uppercase letters, English lowercase letters, numbers, and special characters. (support up to 64 characters)
- If the password is 10 characters or longer, it must include at least 2 of the following character types: English uppercase letters, English lowercase letters, numbers, and special characters.
- ID may not be used as password. The password and ID cannot be identical.
- The following special characters can be used: ~!@#\$%^&*()_-=+{ }[]\|;:'",.<>.,/?
- You may not use more than 4 consecutive characters. (example: 1234, abcd, etc.)
- You may not use the same character 4 or more times consecutively. (example: 1111, aaaa, etc.)

- Если новый пароль имеет длину 8 или 9 символов, вы должны использовать минимум 3 типа символов из перечисленных: заглавные латинские буквы, строчные латинские буквы, цифры и спецсимволы. Настройка камеры

- 1 Подключите переходник OTG (5-контактный) и аппаратный ключ WiFi к соединителю micro USB.

Настройка смартфона

- 1 Установите приложение для установки Wisenet.
- 2 После соединения с WiFi выберите SSID камеры.
- 3 Запустите приложение установки Wisenet.
- 4 После входа в систему камеры будет подключено видео.
 - Во время первоначального подключения видео будет воспроизводиться без входа в систему.
- 5 Угол обзора камеры можно регулировать во время просмотра видео на смартфоне.
